

1. **How to Enter:** Beginning at 9:00 a.m. Eastern Time (“ET”) on October 1, 2020 until 4:00 p.m. ET on December 15, 2020 (the “Sweepstakes Period”), you may enter the Hawthorne Area Chamber of Commerce (HACC) Shop Local Sweepstakes (the “Sweepstakes”) by bringing a qualifying document dated October 1, 2020 – December 15, 2020 from current HACC members to the HACC office, or email them to [HawthorneChamber@hotmail.com](mailto:HawthorneChamber@hotmail.com) and submit your name, phone number, and email address. Limit of one (1) entry, per qualifying document. Qualifying Documents include, but are not limited to, HACC member retail receipts, church programs or copies of tithe payments, copy of paid bill to HACC member (ie, City of Hawthorne, Waste Pro, Clay Electric, Florida Power & Lights, etc), signed business cards from non-retail members (ie, Realty Service, etc), service agreements with HACC members... Other documents not mentioned must be approved by the HACC president. Qualifying documents must include the business name and date.

HACC reserves the right to select the winner in a random drawing format that shall be determined by HACC President.
